Urshataw Muu Declaration for Yurumie

We are the Indigenous Urshataw Muu Global Sovereign Nationals, the true and de jure natural living man, in body, mind, and spirit and the divine heirs to the land. We are the descendants of the natural sentient beings that you refer to as Caribs, namely the Kalinago and Gaifuna people, and of the Ancient Sentient Ancestors, Mayans, Aztecs, and Olmecs. We are in Propria Persona Sui Juris, In Proprio Solo and in Proprio Heredes and we are exercising all of our rights at this time and at all points of time.

We, the Indigenous Peoples, Declare the Following:

1. All LAW of Land, Air and Water created is entrusted to all capable living man and woman of the Earth. First Nation is the original people of the land which is known as indigenous people. First Nation is the only nation that has priority and power over anything or any nation that is a foreign entity. There is no law that gives any foreign entity any rights over First Nation. Urshataw Muu Nationals as custodians and creditors, heir of the land Yurumie, are Capable Sovereign Sentient living men and women, and therefore have the right to live on this Earth with no violation or hinderance.
2. There is no law that gives any corporate, foreign entity such as St. Vincent and the Grenadines, any right or jurisdiction over First Nation. First Nation is the original owner and the heirs of this landmass/island called Yurumie. Therefore, the state must pay tax to First Nation. The state must contribute to First Nation for any developing structure, corporate business, and all corporate entity that is found/occupied on the island Yurumie.
3. SAINT VINCENT AND THE GRENADINES is just a mere foreign corporation, on the indigenous soil of Yurumie land, registered by the crown. The British commonwealth Registered Corporation Dun and Bradstreet Numbers 01628 49200 and 0845 1451700 dissolved on 20 November 2012. Therefore, take notice, to all sentient men and women holding and acting in such political offices as public officials, government officials, representatives, agents and servants; be it known unto you that the corporation of St. Vincent and the Grenadines, as a corporate entity, has no legitimate government function

4. All legislation declared to be laws constitute “color of law” and a fraud; as said legislation constitute corporate policies which are enforceable only upon corporate entities and employees, and to which the indigenous people of Yurumie are not subject.
5. It is not lawful that you be on indigenous land Yurumie with your corporate agents enforcing and upholding statute laws against indigenous people.
6. On the landmass Yurumie, the first nation is Urshataw Muu Global Sovereign Nation. Urshataw Muu Global Sovereign Nation operates within Common Law and the Law of Liberty. Here we will build a community with indigenous schools, health care facilities, markets, stores, agricultural farms, industries, and etc., with our long heritage and resources to be fully sustainable without any dependency from outside sources.
7. Any property owned by each Urshataw Muu National, such as automobiles, lands, houses, natural resources, boats, planes, sweat equity, trading products [import and export] etc., are not subjected to taxation or violation by your corporate state.
8. Under no circumstances will we tolerate any violation, coercion, threat or duress by any agent, security forces doing their statute performance. With the inclusion of all settings, whether it be on the highways or in public places, agents shall not try to assess sentient indigenous Urshataw Muu Nationals as citizens. This will be a violation that is not accepted and will be prosecuted with all extent of the law.

Indigenous peoples will have their own security and military forces. Foreign military activities shall not take place in the lands or territories of indigenous peoples. Indigenous peoples have the right to peace, security, and protection in situations or periods of internal or international armed conflict pursuant to International Humanitarian Law which a. Shall not recruit indigenous children and adolescents into the armed forces under any circumstances; b. Shall take measures of effective reparation and provide adequate resources for the same, for the damages incurred caused by an armed conflict. c. Shall take special and effective measures in collaboration with indigenous peoples to guarantee that indigenous women and children live free from all forms of violence, especially sexual violence, and shall guarantee the right to access to justice, protection, and effective reparation for damages incurred to the victims.

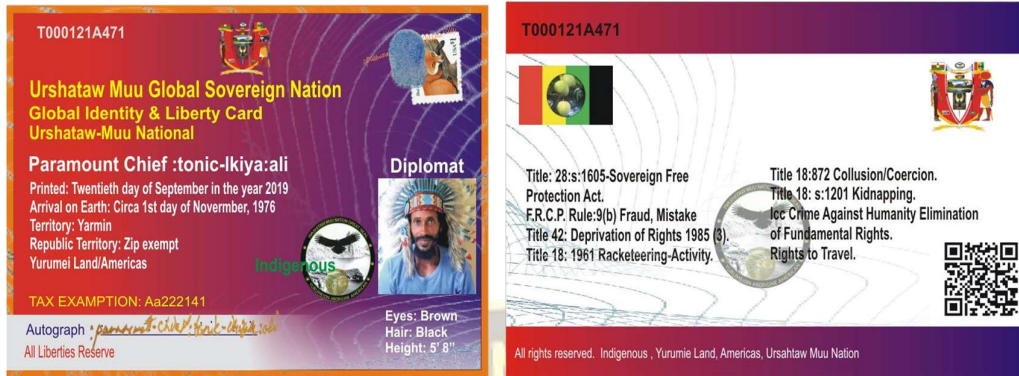
Navigation Rights of Urshataw Muu Nationals:

- By boat, plane, or traveling in our convoy- Urshataw Muu Nationals are sentient beings not subject to tax or any corporate statute regulation.
- Urshataw Muu Nationals are sentient diplomats that are not subject to any form of corporate regulations; state laws do not apply. Urshataw Muu Nationals are not under any jurisdiction of the state and operate within common law and law of liberty. The state is under the jurisdiction of Urshataw Muu land Yurumie. Our laws are pertaining to our indigenous nation and our constitution.
- By use of indigenous ID, facts of arrival, etc., to purchase or do business by use of all Banks, Credit Unions, FedEx, registered mail, transaction with immigrations, business transactions by Money Gram or Western Union, the Urshataw Muu Nationals deserve respect and for all agents to be notified that the indigenous people have the right to trade and do business without discrimination.
- The regulation of the tax-exempt number must be acknowledged and followed by all businesses and corporations; that when used by the Urshataw Muu Nationals, all tax and regulations must be exempt from all entities and is recorded and recognized within all systems.
- This is a head of notice that all state agents and corporate businesses must follow; failure to do so will be implicated in bonds and lien.

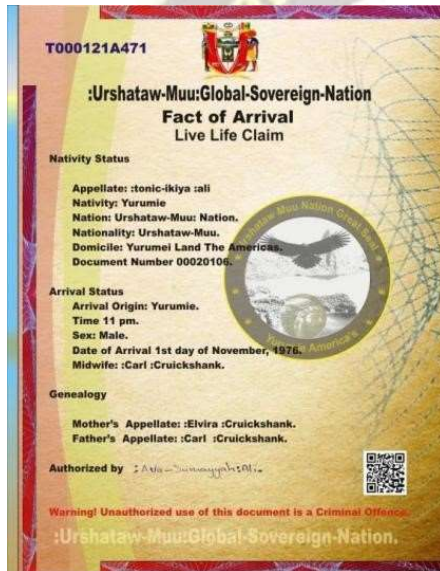
